

## PIZZA HUT'S HUTTY SWEEPSTAKES OFFICIAL RULES

- 1. Sweepstakes Period:** The Pizza Hut's Huttly Sweepstakes (the "**Sweepstakes**") begins at 6:00 PM Eastern Time ("**ET**") on March 19, 2025 and ends at 11:30 PM ET on April 8, 2025 ("**Sweepstakes Period**").
- 2. Eligibility:** The Sweepstakes is open only to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older as of the date of entry. Employees of Pizza Hut, LLC (the "**Sponsor**"), the National Collegiate Athletic Association® ("**NCAA**"), their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies, and their immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate or win. Void where prohibited by law. All federal, state and local laws and regulations apply.
- 3. How to Enter:** During the Sweepstakes Period, entrants may enter by visiting pizzahutshuttysweeps.com ("**Website**") to complete the registration form ("**Entry**"). All Entries must be received by 11:30 PM ET on April 8, 2025 to be eligible. Limit one (1) Entry per person during the Sweepstakes Period. Any attempt by any entrant to enter by using multiple/different email addresses, mailing addresses, identities, registrations and logins, or any other methods will void such Entries and that entrant may be disqualified. Use of any automated or computer system to participate online is prohibited and will result in disqualification. Normal Internet/phone access and data/usage charges imposed by your online/phone service may apply.
- 4. Random Drawing:** Ten (10) Grand Prize winners, one (1) First Prize winner, six (6) Second Prize winners, seventeen (17) Third Prize winners and sixteen (16) Fourth Prize winners will be selected in a random drawing on or about April 9, 2025 from among all eligible Entries received during the Sweepstakes Period. The random drawing will be conducted by an independent judging agency whose decisions are final and binding on all matters relating to the Sweepstakes. Winner Notification:** Each potential winner will be contacted via email and asked to provide/confirm their address/eligibility/size choice (as applicable) within two (2) business days or prize may be forfeited and an alternate winner may be selected for the applicable prize. Return of any prize notification or prize as undeliverable or if an entrant is not eligible, will result in prize forfeiture and an alternate will be selected.

Proof of Entry will not be deemed to be proof of receipt by Sponsor. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. "Authorized account holder" of an email address is the natural person in whose name the email address has been issued. Sponsor reserves the right to cancel, suspend and/or modify the

Sweepstakes, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion, and in the event of cancellation, the prizes will be awarded in a random drawing from among all eligible Entries received prior to cancellation.
